## Photo Contest

### Rules and Regulations

**Eligibility:** The MY OAKVILLE PHOTO CONTEST (the “Contest”) is only open to residents of the Province of Ontario age (accompanied by parental consent if under 18 years of age.) Notwithstanding the foregoing, the Contest is not open to employees, representatives and agents of OAKVILLE PLACE, IVANHOE CAMBRIDGE I INC., IVANHOE CAMBRIDGE II INC, PARTICIPATING OAKVILLE PLACE MERCHANTS, THE OAKVILLE BEAVER (collectively, the “Contest Sponsors”) or any retailer located in the Contest Sponsors, or the Contest Sponsors’ affiliated companies, advertising and promotional agencies, and all persons with whom any of the foregoing individuals are domiciled or members of their respective immediate families.

All times refer to Eastern Daylight Time (“EDT”). Contest is void where prohibited by law.

Approved entries will be posted on the OAKVILLE PLACE website for public viewing and access. First names and last initials will be included with each online entry. **Selected photos will be printed for in-mall promotional purposes.**
3. **Photos must be the following size and format: Images must be JPG, 1024 x 768, 72dpi, No more than 2mb. Please no cell phone photos. Entrants may be contacted to submit the original image for in-mall promotional purposes.**
4. The Contest Voting Period begins on July 26, 2010 at 9:30am and ends at 11:59pm on August 2, 2010. During the Voting Period all entries on the OAKVILLE PLACE website can be voted upon, with one vote permitted per email address every six hours.
5. The top People’s Choice entry with the most online votes of all submissions will each receive a \$1000 Oakville Place Gift Card. Two runners up in each category will each receive a \$250 Oakville Place Gift Card

6. "Professional judges will award THREE \$1000 Oakville Place gift cards to the overall best photo in each of the 3 age categories (under age 12, age 12-19 and age 20+) as judged by a panel of judges including a professional photographer from the Oakville Beaver."
